# TID ROLLOVER – Vending Key Extension

To be completed by 24 **November 2024**

# Vending Key Extension

The STS Association acknowledges that with only a few months left until the cut-off date (24 November 2024), not everyone may have completed their TID rollover campaigns. As it stands, all current 1993 base date vending keys will expire on the 24<sup>th</sup> of November 2024 which means that no further TID Rollover Key Changes can be generated thereafter. To mitigate this risk, the STS Association has developed a technical solution to extend the validity period of these 1993 base date vending keys. This extension, which expires on 31 May 2025, is restricted to the generation of TID Rollover Key Change Tokens only, and credit purchases on these vending keys will still not be possible after the cut-off date.

# Vending Key Extension

The extension is only for people that have not managed to complete the TID RO program. If the meter runs out of credit on the 24<sup>th</sup> Nov 2024 and the TID RO has not been done, the meter WILL stop dispensing credit, so it is a D date. However, the meter can be rolled over after this date since the key extension will then allow this.

If the meter still has credit in it after the 24<sup>th</sup> Nov 2024, it will keep dispensing credit until it runs out – during this time, the RO will be possible if the key extension is utilised. Currently, this RO after the 24<sup>th</sup> Nov is not allowed since the keys will expire in the HSM on the 24<sup>th</sup> Nov.

The key extension can be done on a bulk or individual basis in the KMC.

# Vending Key Extension

The key extension does NOT mean that the rollover date has moved from the 24<sup>th</sup> November 2024, it simply means that the HSM will still allow you to do the RO after that date. Without the key extension, the RO project MUST be completed for every meter in existence (even meters in warehouses) by 24 Nov 2024. With the key extension, the HSM will allow the RO to be done after 24 Nov 2024.

# Vending Key Extension

In summary:

1. The KRN1 keys will expire on the 24<sup>th</sup> Nov 2024 and the HSM will not allow a RO to be done after that date (without the key extension)
2. The key extension will extend the validity of these keys in the KMC so that the HSM will still be able to do RO keychanges after 24 Nov 2024 (for example for meters in warehouses) if a new KLF is requested from the KMC
3. Meters that have no credit left on the 24<sup>th</sup> Nov 2024 will stop dispensing credit (D Date) and no new credit will be able to be purchased until the RO is done
4. Meters that still have credit after 24Nov 2024 will continue dispensing credit until the credit runs out – during this period, the RO can still be done if the keys have been extended.
